- Para reclassificacao geral obrigatoria 50% reducao nas taxas
- To reclassify is 50% reduction on the taxes
- Para a deslocacao dos tecnicos é adicionada uma taxa de 20% sobre a taxa base
- To arrange for the inspector to arrive is an additional 20% on the tax base
- Estabelecimentos com menos de 10 quartos esta sujeito apenas a taxa base
- Establishments with less than 10 rooms is subject only to tax base
