Ministerial Diploma no.th18/2024:

Updates the fees charged for concession, renewal, extension or replacement of the Passport, travel documents, visas and DIRE and revokes Ministerial Diploma no. 65/2019, of 5 July.

It becomes necessary to update the fees charged for the granting, renewal, extension or replacement of the Passport, travel documents, visas and DIRE, under paragraph 2 of article 2 of Decree no. 108/2014, of 31 December, amended by Decree no. 46/2022, of 16 September, in conjunction with no. 2 of article 5 of Decree no. 13/2008, of 29 April, the Ministers of the Interior and of Economy and Finance, determine:

Article 1. Fees charged for the granting, renewal, extension or replacement of Passports, documents of

travel, visas and DIRE, are set out in Annexes 1, 2, 3 and 4 to this Ministerial Diploma, which are an integral part of it.

Art. 2. The fee charged for the issuance and extension of visas, as well as for the issuance, renewal or replacement of DIRE respects, whenever applicable, the provisions of the agreements concluded between the Republic of Mozambique and other States and International Organizations.

Art. 3. The fee charged for the issuance, renewal, extension or replacement of DIRE, in relation to citizens of the Community of Portuguese Speaking Countries (CPLP) is set out in Annex 3 to this Ministerial Diploma, in accordance with Resolution no. 42 / 2004, of 22 September, which ratifies the Agreement on the Exemption of Fees and Fees due for the issuance and renewal of Residence Permits.

Art. 4. Diplomatic, Official and Courtesy Visas are exempt from payment of the fee charged for their issuance and extension, when there is reciprocity of treatment.

Art. 5. Revenue from the collection of fees for granting, renewing or replacing the Passport, travel documents, visas and DIRE is intended to fulfill the obligations assumed with the awarded entity for the manufacture of Passport, travel documents, visas and DIRE.

Art. 6. The remainder of the revenue referred to in the previous paragraph has the following destination:

The) 50% for the National Migration Service;
It is *B*) 50% to the State Budget.

Art. 7. The revenue referred to in article 5 of this Ministerial Diploma must be channeled in its entirety to the Public Treasury, which must ensure its delivery to the respective Fiscal Area Directorate.

Art. 8. Ministerial Diploma no. 65/2019, of 5 July, is revoked.

Art. 9. This Ministerial Diploma comes into force on the date of its publication.
